Terms of Use

Please read these legal terms of use (together, the "User Agreement") carefully before using the BEACON website (<u>www.beaconbio.org</u>), making a contribution to this website, or otherwise accessing or downloading any information from this website (the "Site"). 1. Acceptance of terms of use.

By accessing or using the Site, you hereby accept and agree to comply with this User Agreement. You represent and warrant that you have the full legal authority to enter into the User Agreement and if you are acting on behalf of an organization or company, you have the legal authority to bind such organization or company to the User Agreement.

2. BU grants you a limited right to use the Site.

BU hereby grants you a limited, revocable, non-exclusive, non-transferable and non-sublicensable license to use the Site. If we are unable to resolve a dispute within 60 days, either of us has the right to initiate arbitration. Any statute of limitations will be tolled during this informal resolution process.

You and BU agree that disputes must be brought on an individual basis only and may not be brought as a plaintiff or class member in any purported class, consolidated, or representative proceeding. Class arbitrations, class actions, and representative actions are prohibited. Only individual relief is available.

13. Changes to the User Agreement.
